Report from County Councillor: County Councillor Patrica Stallard was in attendance giving an update on the Hampshire County Council Future Services Consultation, explaining the Authority needs to meet a £132 million budget shortfall by April 2025. Consultation closes 31st March. Councillor Stallard also updated on HCC's new policy on 20mph speed limits has now been introduced. The new policy allows the council is to introduce speed restrictions where there is a proven safety need for them. Communities will need to fund the introduction of the schemes.

Reports from District Councillors: District Councillor Angela Clear updated on the Mayors awards, which recognises and celebrates the organisations and individuals who have given outstanding service to the people of Winchester District. Nominations close 18th February. District Councillor Chris Chamberlain updated on fly tipping, latest data shows that fly tipping across the Winchester District was down 40% in 2022/23 compared with 2021/22, as well as updating about the City Councils support for Wickham Surgery and limiting the catchment for the Welborne Development to the first phase only. Councillor Chamberlain also asked about the process for approving the Budget and Precept, which was discussed during agenda item 11.
