5.1 Case No: 24/01126/FUL

**Location:** Mayles Farm Mayles Lane Wickham Fareham Hampshire PO17 5ND **Proposal:** Full application to support new agricultural access onto Hoads Hill (A32)

Wickham

#### Comment:

Wickham and Knowle Parish Council **OBJECT** to this application

The supporting traffic note (TN), states that the proposed access will allow the landowner to better farm fields which are currently accessed via Mayles Lane. Yet the land is not used for farming. The site currently operates as an equestrian livery yard. The applicants own masterplan webpage for the site https://www.macra.ltd/mayles-farm/ does not provide any reference to the fields being used for agricultural purposes but states that 'Mayles Farm is currently used for commercial equestrian liveries, therefore the fields are used for grazing and are of low environmental value'.

No evidence has been provided to demonstrate the quantum, pattern or distribution of these agricultural trips. No evidence has been provided to demonstrate how many farm vehicles from the site currently use Mayles Lane.

The TN has not provided any evidence of how many farm vehicles from the site use Mayles Lane, other than that the number is 'modest'. As these are likely to form only a very small part of overall vehicle movements (including large lorries and HGVs). The TN has not provided any accident record data for Mayles Lane, or any accident record data to suggest that the geometry of Mayles Lane/A334 junction is resulting in a pattern of accidents.



## Wickham and Knowle Parish Council

The TN has not provided tracking drawings to show that the junction cannot be used by larger vehicles, or any evidence that the movements are currently problematic to the applicant or to other residents/users of Mayles Lane. There is therefore no evidence to suggesting that the proposed access will provide any betterment to Mayles Lane.

The Parish Council cannot determine applications with such little information provided. The application is to form a bellmouth junction onto the A32/Hoads Hill, with a 10m/15m corner radii to the north and south respectively, and an 8m access road, narrowing once

The location of the junction on Hoads Hill would cause serious safety issues. A 50mph road, with slow farm traffic slowing to turn is not safe.

within the site. No surveys have been carried out on the A32 for this application.

The TN suggests that the new access will result in carbon savings through reduced journey length and time. They have provided no evidence for this, but have themselves described the number of movements as 'modest'. The reduction in journey length and time would also be modest, given the proximity of the existing access to the proposed, however, there would be considerable carbon impacts associated with the construction of a new access.

As part of the Welborne development (application reference: P/17/0266/OA), a number of improvements will be made to the A32 carriageway, as summarised below:

- Introduction of cycle lanes on A32 Hoad's Hill, through the removal of the second southbound lane.
- New pedestrian crossings on Hoad's Hill.
- New shared use paths, including connection to the southern edge of Mayles Farm

LTP4, Policy HP1, aims to deliver the infrastructure required to support a large-scale shift towards walking and cycling for everyday trips. And states it will: ensure that any changes to the highway infrastructure prioritise walking and cycling, in line with Road User Utility Framework and Movement and Place Framework, Walking and Cycling Principles, and national policies.

The improvements secured through the consented Welborne development fully support Policy HP1.

The access proposed through this application would result in a disbenefit to this infrastructure scheme by creating another point of severance/disruption to a new, high-quality cycling and walking route, and would be contrary to Policy HP1.



## Pre-planning consultation on the proposal to build a new 900 place secondary school on land at North Whiteley due to open in September 2027

Hampshire County Council wishes to consult with you ahead of the proposal to submit a planning application for a new secondary school at North Whiteley.

#### The proposal

The area around Whiteley in southern Hampshire has experienced significant redevelopment in recent years. Initial development provided 2,000 new homes and a further 3,500 homes are planned as part of the development known as North Whiteley, 1,500 of which are already occupied.

Hampshire County Council will be building a new 900 place secondary school which also includes a Special Educational Needs and Disabilities (SEND) Resourced Provision to serve the new housing development at North Whiteley. The new secondary school is planned to open in September 2027 for ages 11-16 years, admitting up to 180 students per year group.

The school will initially be built with 900 places (180 per year group) but is being designed to allow expansion by a further 300 places (60 per year group) should future local demand require.

This pre-planning consultation will run from **Monday 2 September** to **Monday 30 September 2024.**

#### **Next Steps**

The purpose of this consultation is to seek the views of stakeholders in the community on the proposed new school. It is important to the County Council that the views of all stakeholders who may be affected by the proposals are carefully considered.

Any comments received will be considered prior to the planning application for the new secondary school due to be submitted in October 2024.

#### **Linked Consultations**

This consultation follows an earlier, separate consultation on the future education offer for children in Whiteley and Fareham. Feedback from that separate consultation, as well as a recommended way forward, will be presented for consideration to Councillor Roz Chadd, the County Council's Cabinet Lead Member for Children's Services, at a Decision Day meeting on 25 October 2024. Subject to the outcome of that Decision Day, a further consultation will be undertaken as required.

#### TITCHFIELD LANE BATTERY ENERGY STORAGE SYSTEM PROPOSAL

I am writing to you on behalf of Grenergy Renewables UK, regarding our development plans for a new 50MW Battery Energy Storage System (BESS) in your area.

Grenergy Renewables are an Independent Power Producer that designs, develops, implements and operates renewable energy plants across the globe. Our business model covers all phases of a project's lifecycle, from development, through to construction, plant operation and maintenance, and financial structuring and asset management.

Battery Energy Storage Systems (BESS) are electrical storage plants connected into the grid network that enable surplus energy generated from renewable generation, like solar and wind, to be stored when that energy cannot be utilised and then discharged into the network when the power is needed most. BESS can also operate in several different modes to provide grid with essential stability services. The UK government estimates that technologies like BESS, which supports the integration of low-carbon power, can help save the UK energy system up to £40 billion by 2050.



The proposed site would be located off Titchfield Lane, Hampshire, PO15 6DY, and covers approximately 1.5 hectares, including land for proposed landscaping measures and biodiversity net gain.

The chosen site is selected due to the proximity to Botley Wood substation, located south-west, where the project has capacity to connect into the local grid network via an underground connection.





Our indicative timeline for the development of the project is:

- July 2024: EIA Screening request submission (Ref: 24/01656/SCREEN)
- October 2024: Planning submission to Winchester City Council
- Spring 2024: Anticipated planning determination
- Spring 2025: Construction starts (subject to grid connection works)
- Autumn 2026: Operational

At this early stage of the project, we are looking to engage with key local stakeholders to gain an enhanced understanding of the area, local community, and potential matters of interest, to help inform our final proposals.

As a key stakeholder in the area, we value your opinion and feedback and would therefore like to offer a meeting to introduce the project and discuss any questions or information about the local area you may have.

Subject: Moving forward with resolving the safety issues at the Little Tapnage Bridge

Good afternoon, Clerk & Councilors

I am aware that you may have previous knowledge of Little Tapnage Bridge, this bridge is located over the bridleway, that runs along the disused rail line, approximately 1.5km south of Wickham. This has previously been brought to the Parish Councils attention possibly as far back as 2017, following concerns over its safety and the eventual closing the Bridleway.

For the last four and a half years the end of this disused rail line has been closed due to critical safety concerns regarding the structural integrity of the bridge. The Council has explored all options (including repair which would have cost in the region of £1m), looking for a viable solution. The good news is that we have finally achieved traction with the landowners, and all are now on board with our plan to make this area safe and re-open this last section of the disused rail line and the Bridleway. This is a critical section, as it will facilitate greater enhancements next year as we connect south and into Fareham. As you are aware it has taken some years to get here, so we are acting rapidly to move this matter forward and reopen the bridleway.



Since our last communication with you, we have been working with the local landowners and farmers and have been seeking legal advice. Most recently receiving an updated structural engineer's report who in March 2024 stated:

- The extensive cracking observed in the parapet poses a severe safety risk, rendering it ineffective as a barrier against vehicle accidents and posing a threat to pedestrians below due to falling bricks.
- Additionally, the failure of the wingwalls, which support the approach track to the bridge, adds to the
  existing issues.
- Continued use by agricultural vehicles and trailers is likely to worsen the damage, eventually leading to the collapse of the wingwalls and rendering the track impassable.
- Considering the extensive cracking beneath a continually used but closed public right of way, there is a significant risk to Public Health.
- Urgent measures are necessary to prevent pedestrian traffic beneath the bridge and heavy agricultural
  vehicle traffic over it.

As part of the comprehensive planning, we have taken the details of the report, and we have drawn together a plan which will see the bridge safely demolished and replace with a ramp. We must replace access for farmers to access land south of the rail line, this will be delivered via a gated service ramp crossed by the reopened Bridleway.

The Council recognises the heritage of this structure and is reluctantly taking this action. We will be seeking to save a number of the key stones used in the arch and from the parapets and will look to use these, in some way, when the route is opened south wards to interpret the disused rail line, the Meon Valley Trail and its landscape.

The work to demolish the bridge will commence in early September 2024 and to reopen the Bridleway by the end of this year. Over the coming years, utilising already secured developer funding, this dead-end route will connect on a surfaced route, south through conservation land created by the Knowle development and all the way through to and beyond the Welbourne Development. Our project team are currently exploring options to extend the route further into Fareham.

To summaries the key dates over the next stages of the project:

Health and Safety Tree works are due to commence on the 27<sup>th</sup> August, with demolition contractor starting on site on the 2<sup>nd</sup> September

 This is the 2nd year that this event has been granted a TEN notice, with no consultation to the neighbours that it affects. This year it was advertised as "bigger than ever "and it was! The field was crammed with tents, camper vans, a marquee, gazebos, toilet blocks & food vendor vans, that arrived Friday 26th July & in the main, departed Sunday 28th.

- 1 week before this, we were disturbed until 21.00 on frequent evenings by the field owner carrying out works with diggers & machinery in preparation for the event.
- The field has neighbours on all 4 sides -North, South, East & West ..... properties on the Southwick Rd; Hundred Acres Rd; the Hundred Acres, "Firgrove house, Granada, Chantry, Pebbles, Strawberry barn " It is not suitable for a large noisy festival, whether it be a "family friendly" event and in aid of the Air Ambulance.
- This year the marquee, and centre of activity was moved to the northern end of the field - right opposite our properties "The Birches" & "The Birches annexe".. and "Firgrove House" & "Pebbles". I believe this was to cause less inconvenience to the "Winscombe "Care home on the Southwick Road, but it caused more noise pollution for us!

#### Meeting with KC regarding Local Plan

- Letter sent by WCC in 2022 has a paragraph which allows them to review their stance
  in the future. This means they can lawfully go back on what they said. The KC also
  said they would have had to put this disclaimer in the 2022 letter, as the local plan is
  "community led" so they would need to be able to make changes based on
  consultation. Which is what they have done.
- There is no argument around the Ravenswood site. Once the S106 is to the Councils satisfaction it must be signed. We can't withhold a signature.
- We can't see the developer representations until published. Which will be at the same time as the parish councils, so wont be able to respond to specifics. We need to be clear when this will be and whether we aim our objections at WCC during consultation stage or at the Inspector as he reviews the Plan.
- The developers will be arguing that Wickham is sustainable. There is little argument to disprove this.
- Focus should be on the extra allocation of 100 houses, and the mill lane site.
- There is perhaps an argument that the 100 houses are not driven by the community (the plan is meant to be), and that the developers should not be influencing Wickhams allocation. It is not what the community want.
- The Inspector will receive hundreds if not thousands of representations to go through. In order to stand out it is best to offer a solution. A potential solution being that we say "we don't want the 100 houses, but if we get them then we would like them all to go on the Glebe". Then give reasons Mill Lane is not a suitable site.
- Mill Lane the developer/promoter of this site will say "highways issues will be dealt
  with as part of the application". The Council need to clearly explain why this is not a
  suitable site, and it needs to be from "experts" not a "in our opinion". So KC is
  suggesting a highways consultant should be instructed as part of future work.
- Representation needs to be made around the work the PC has been doing on the Mill Lane site and sports pitches and provide evidence that the sports pitches are not affordable.
- Some spatial awareness work needs to be done to explain the location of Wickham and Knowle and the impact of the Welborne development, plus the Ravenswood site
- There is little value in presenting arguments at the Scrutiny Committee. This
  committee really just sense checks ahead of Cabinet. A formal response is required
  during the official consultation period. This will go to WCC and the Inspector.

Action arising:

- Need to decide whether or not to speak at the scrutiny Committee in light of KC advising no real benefit and keeping our "powder dry"
- The PC should devise a strategy for developing strong arguments and presenting evidence to support them for the housing site choices and why Mill Lane is not suitable for either housing or sports. This needs to consider the timetable fr consultation and Inspector review
- PC should consider engaging KC to advise on work we should do to provide the evidence and determine budgets for them

Apologies for not getting back to you sooner – I have been away on holiday.

Here are my thoughts:

- I agree it is essential that we submit a strong consultation response. We should aim to make this as complete an objection as possible, but we will have the opportunity to supplement it ahead of the Examination in Public.
- We need to identify the specialist areas in which we need expert input to support our case. On the basis of our discussions to date we'll obviously need to appoint a highways consultant to explain why the proposed allocations would be unacceptable in terms of highway safety / capacity. I think we will also need to appoint a planning consultant to explain why the plan is unsound in terms of planning policy and also to co-ordinate the submission. But we can discuss that, as there may be scope for us to do that 'in-house'?
- My role would be to review the overall consultation response, i.e. to review first drafts and to advise
  how we can make it as strong as possible. There may also be scope for me to write an opinion for
  submission to the Council as part of the consultation response, but we will need to discuss that once
  we have our draft consultation response up and running.
- In terms of fees, I've cc'd Kevin my practice manager into this so he can give you a fee quote.

Hope that's helpful. Very happy to have a word on the phone if that would assist.

Good afternoon Rob: I hope all is well.

The Parish Council has discussed the way forward with our intention to raise objections to the Local Plan during the consultation and inspection stages of the plan process.

It is obvious that we need the support of experts in planning to make a decent fist of this and would like to get a clear idea of the processes and likely costs of what you feel you might be able to do to help us.

Is it possible, with what you know already, to outline an approach you might make to the issues we have raised and give an estimate of likely costs/hourly rates?

As a reminder, we are trying to:

Remove the need for an additional 100 houses in Wickham – failing which, to have all the houses located on one (PC preferred) site instead of split over two

Alter the plan for a sports centre in Mill Lane to a country park

One of the major reasons for wanting these changes is the poor road network serving the Mill Lane area where the non-preferred site and the Sports centre are supposed to be located. Opposition to the sports centre is supported by financial analysis. I am sure there are other pieces of evidence we should develop including the pressures that will arise from juxtaposition to the new garden "village" at Welborne (6000 houses).

Happy to offer further information but perhaps this is enough to get a ballpark outline from you?

Firstly, yes I can help and would be happy to do so.

The consultation process on the R19 draft plan stage has a defined structure the City Council (and consultees) must follow. It will publish a notice asking for representations which must relate to the 'legal compliance' with the statutory process for preparing a plan, and the 'soundness' of the plan against the tests which the examiner will use at a later date. That doesn't mean Wickham won't be able to raise the points it wants to, but it will need to frame and keep them focussed within that structure.

Preparing the response would require no more than 2 days work at £400 per day - so a maximum cost of £800.

I will give you a ring later if that's OK just to talk through the process in a little more detail.
